## **Washburn Rural High School Extracurricular Activities**

### **Alcohol, Drugs, & Tobacco (Simulated Tobacco) Policy**

Washburn Rural has established comprehensive policies of zero tolerance for students who are involved with Alcohol, Drugs, & Tobacco. There are consequences outlined in the discipline policy for incidents that occur while a student is in attendance at school or school activity. This policy establishes consequences for student participants who consume or are in possession of Alcohol, Drugs, or Tobacco inside or outside of school. This policy is intended to not only provide protection for student participants, but to protect the integrity of the programs they represent.

Participation in high school activities is a privilege, not a right. Students who earn a spot on a team or group have behavioral expectations supported by all coaches/sponsors and administrators. These expectations are also supported by the policies here within.

Washburn Rural is a member school of the Kansas State Activities Association. Part of their policy for participation clearly states "in order to participate a student must be in good standing." A student deemed not in good standing due to consumption or possession of alcohol, drugs, or tobacco will forfeit, at minimum, a portion of their eligibility.

#### **Alcohol, Drugs, & Tobacco Involvement at School**

The Auburn-Washburn Board of Education's approved discipline policy addresses and spells out the consequences for students who violate rules involving alcohol, drugs and tobacco at school or school activities. Those policies are listed in the student handbook and are reviewed with the students at the beginning on each school year. Students involved in extracurricular activities who violate the policy will face School consequences and the Extracurricular consequence.

#### **Alcohol, Drugs, & Tobacco Involvement Outside of School**

If a student participant is found to have consumed or possessed Alcohol, Drugs, or Tobacco during the school year outside of school they are also subject to consequences relating to their eligibility.

#### **Tobacco or Simulated Tobacco (Nicotine Vaping)—**

##### **1st Offense—**

- School Consequence—3-hour detention & 3 points
- Extracurricular Consequence—Suspended for the next competition

##### **2<sup>nd</sup> Offense—**

- School Consequence—1 Day Suspension
- Extracurricular Consequence—Student will forfeit 20% of scheduled competitions \*\*

##### **3<sup>rd</sup> Offense—**

- School Consequence—3 Day Suspension
- Extracurricular Consequence—Student will forfeit one calendar year of competition

## **Alcohol—**

### **1<sup>st</sup> Offense**

- School Consequence—5-Day Suspension from school & 20 School Day Suspension from all student extracurricular performances, competitions, or social functions
- Extracurricular Consequence—Student will forfeit 20% of scheduled competitions \*\*

### **2<sup>nd</sup> Offense**

- School Consequence—Recommendation for Long-Term Suspension
- Extracurricular Consequence—Student will forfeit one calendar year of competition from the date of infraction.

### **3<sup>rd</sup> Offense**

- School Consequence—Recommendation for Long-Term Suspension
- Extracurricular Consequence—Student will forfeit any remaining eligibility.

## **Drugs—**

### **1<sup>st</sup> Offense**

- School Consequence—Recommendation for Long-Term Suspension
- Extracurricular Consequence—Student will forfeit 20% of scheduled competitions \*\*

### **2<sup>nd</sup> Offense**

- School Consequence—Recommendation for Long-Term Suspension
- Extracurricular Consequence—Student will forfeit one calendar year of competition from the date of the infraction.

### **3<sup>rd</sup> Offense**

- School Consequence—Recommendation for Long-Term Suspension
- Extracurricular Consequence—Student will forfeit any remaining eligibility.

### **Additional Information (\*\*)**

If the violation occurs during the student's off season, the Extra Curricular consequences will be imposed at the beginning of the student's next season of competition.

If the violation occurs near the end of a student's participation season, consequences will carry over to the student's next season of competition.

If the violation occurs during the season consequences will be enforced concurrently and the longer consequence takes priority.

Students who violate the Drugs, Alcohol, or 2<sup>nd</sup> Tobacco offense part of the policy out of season may choose Community Service, approved by the Athletic Director, & completion of a Substance Abuse program to reduce 1<sup>st</sup> Offense forfeiture to 10% of competitions.
